I, Leitoni Tupou, being first duly sworn, state as follows:

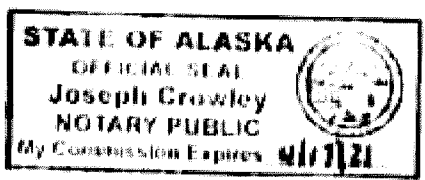
1. I make this affidavit based upon my own information, knowledge and belief.

3. I was involved in the Michael J. Dunleavy campaign for Governor. Among other involvements, I served as:


- a. the South East Alaska Deputy Treasurer;
